## Requirements for Government Ministries, Departments and Agencies (MDAs)

- 1 Certificate of incorporation if incorporated otherwise, a copy of the relevant legislation establishing the MDA or, where it is not possible provide this due to volume, etc., the MDA will write to NLNG on their letterhead citing the laws that established it.
- Organizational chart showing names and positions of personnel with the MDA's name also shown.
- 3 Quality Assurance/Quality Control (QA/QC) policy statement or, applicable ISO certificates
- 4 Health, Safety and, Environment (HSE) policy statement or, applicable ISO certificates
- Letter from the Ministry of Finance, the Central Bank of Nigeria (CBN) or, any other Nigerian commercial bank (whichever may be applicable) communicating details of their bank accounts.

**Note:** Where NLNG have pre-determined bank account details for the MDA being registered, the requirement for letter from the Ministry of Finance, the Central Bank of Nigeria (CBN) or any other Nigerian commercial bank may not strictly apply, the MDA can communicate its bank account details on their letterhead. The reviewers and, the Master Data officer will confirm from the Business and or, the Finance team, the existence and completeness of the pre-determined bank account details.

For requirements such as, tax clearance certificate, Nigeria Social Insurance Trust Fund (NSITF), the Nigerian Upstream Petroleum Regulatory Commission (NUPRC) Oil and Gas Industry Service Permit(s) (OGISP) formerly, DPR Permit, etc., that may not apply to MDAs, the MDA will notify NLNG on its letterhead that such requirements do not apply to it, being a government establishment.

	This letter will be attached to fields requesting such document, if the field requires date of expiration, a future date will be entered, for the purpose of completing the mandatory requirements.
